developing **AB541**, a tobacco assessment and treatment legislation.

Assemblymember Marc Berman, sponsor of the bill, and his main staffer Elizabeth Schmitt who helped craft the legislation, along with Governor Gavin Newsom who signed it into law, were also recognized for their critical roles in making this law that goes into effect January 1, 2022.

This all began when Dr. Chwen-Yuen Angie Chen expressed her concerns during Assemblymember Berman's coffee klatch gathering at a local library, about the perpetual failure to address tobacco use disorders in substance use treatment programs. Berman's staffer Elizabeth Schmitt worked tirelessly on the language of the bill, collaborating with both Drs. Chen and McDonald, as well as engaging various stakeholder such as the California Consortium of Addiction Programs and Professionals (CCAPP) which resulted in CSAM, ACP (American College of Physicians) and CCAPP becoming co-sponsors and supporters of the bill.

Despite California having the second lowest rate of tobacco use in the country, there is a serious social justice problem when our *SUD programs* rank the **lowest** 25% in the nation in addressing tobacco use (2018 MMWR). This bill is intended to provide support for those receiving treatment for substance use disorder to become free of tobacco or nicotine addiction rather than initiating vaping or smoking or continue to use a drug that sustains all the behaviors associated with their other addictions.

What does this mean for substance use disorder agencies licensed or certified in California? All such programs will need to screen for and a) identify tobacco dependence in all clients, b) provide information on how this might affect their long-term recovery from other substances, and c) recommend treatment or refer for tobacco use disorder treatment. Currently the California Department of Health Care Services is developing plans to inform and monitor agencies regarding implementation of this new law.
