## Now is the Time to Come Together!

"This year, in the face of historic budget and funding cuts, sociopolitical uncertainty, and

that addiction treatment saves lives or that those with addiction have lives that are worth saving.

This year, in the face of historic budget and funding cuts, socio-political uncertainty, and an evolving drug landscape, the refuge that is the CSAM conference is as important as ever. Our theme this year, Street to Symposium, Clinic to Capitol, is a nod to the many roles that we as addiction providers must inhabit. Because we must literally and figuratively meet patients where they are, this year's conference will have sessions that focus on the primary care of people who are unsheltered as well as sessions that focus on the lives and experiences of people who use drugs. This will include special attention to substance use among women, the interfaces between sex and substance use, and an optional evening workshop that will provide a hands-on tutorial on the equipment of substance use and harm-reduction. As we must always practice at the height of the scientific evidence, this conference will highlight the latest understanding in starting medications for opioid use disorder, the potential to use GLP-1 agonists in addiction, and the modern landscape of online gambling. In service to our role as clinicians first and foremost, several sessions will focus on direct patient care issues including how to care for wounds associated with xylazine use, comparing long-acting injectable buprenorphine formulations, and how to most compassionately manage opioid overdose.

We as addiction providers must be advocates for our patients. To help us to make our voices heard, this conference will hold sessions that advise us on current and upcoming legislation, guide us in supporting people experiencing incarceration, and provide us a roadmap for influencing policy decisions in our institutions and governments. Most importantly, every session of this conference will be practical. It is my goal that at the end of every lecture, spicy-debate, or panel, each of us will have learned something that will change the way we practice.

Under the leadership of Dr. Randolph Holmes, CSAM convened sixteen addiction medicine physician leaders from across the State of California to advocate for our industry and our patients on May 7, 2025. The primary focus was to advocate for AB 408 (Berman) the Physician Health and Wellness Program, and the team also spoke with legislators about AB 669 (Haney) which would prohibit concurrent or retrospective review of medical necessity for the first 28 daus of an inpatient substance use disorder stay.

Company and our enthusiastic new executive director, Cheryl Marcell. Despite this challenging time of transition, we had a highly successful 2024 conference in San Francisco under the leadership of Dr. Farah Zaidi. Our Board and Committees continue to promote excellent addiction medicine policy and education. In particular, the Medical Board of California's agreement to ask the state legislator to create a Physician's Health and Wellness Program is an achievement that CSAM along with CPPPH have been advocating for many years. I want to give a special shout out to our immediate past president, Dr. Karen Miotto, and CSAM's first executive director, Gail Jarra, for their persistence with this project.

I am also disheartened by how the restructuring of our federal government presents ongoing challenges for our field. SAMSHA faces potential elimination under Secretary Kennedy's plan to merge it into the Administration for a Healthy America (AHA), which may dilute its impact on reducing overdose deaths and addressing substance use and mental health issues. Both the Center for Substance Abuse Prevention (CSAP) and Center for Substance Abuse Treatment (CSAT) are under SAMSHA, so it's unclear what their fate will be. NIH research faces massive cuts, though for now NIDA and NIAAA have been spared, the cancellation of \$11.4 billion in COVID-era funding for addiction and mental health programs will gravely impact our field. Medicaid also faces potential deep cuts, affecting
