#### **Addiction Medicine Board Exam Preparation Track**

The Addiction Medicine Board Exam Preparation Workshop is designed for those preparing to take the American Board of Preventive Medicine (ABPM) Addiction Medicine Board Exam and is aligned with the Board's exam content Blueprint. The faculty of experienced educators will cover 16 key topic areas, with sample exam questions and rationale provided for answers. Test-taking and study tips will be covered. Registration for the all-day workshop includes access to the online High Yield Question Bank after the conclusion of the conference.

#### **MORNING WORKSHOPS (8:30 a.m. – 12:00 p.m.)**

Option 1: Redesigning Specialty Substance Use Disorder Systems to Better Reach the 95% Even in the midst of the nation's worst overdose crisis, 95% of people with SUD are not receiving specialty treatment because they don't recognize a need for it. The traditional specialty SUD treatment model is structured with high barriers to care that can discourage a large number of people with SUD. SUD is widely recognized as a chronic medical condition, and yet traditional treatment models continue to require individuals already be in maintenance (abstinent) and punish a return to symptoms characteristic of chronic conditions (lapsing or returning to substance use). By using payment reform incentives focused on system design, optimizing outreach and engagement, and integrating harm reduction and treatment, this workshop will describe how Los Angeles County is broadening the reach of SUD services to support patients with non-abstinent goals of care and provide a blueprint for health systems to better reach the 95%.

#### **Option 2: ASAM Guidelines on Benzodiazepine Tapering**

Benzodiazepine tapering remains a complex and often nuanced aspect of addiction medicine. This session will provide a structured overview of the American Society of Addiction Medicine (ASAM) guidelines for benzodiazepine tapering, offering clinicians evidence-based tools to support safe, individualized treatment plans. While the session will begin with a robust educational segment to



orient attendees to the key principles and recommendations outlined in the guidelines, it will also feature audience-interactive components, including small group discussions and real-world case challenges. Attendees will be invited to share difficult patient scenarios in advance or during the session, fostering peer learning and practical application of tapering strategies. Topics will include patient selection, risk stratification, tapering protocols, management of withdrawal symptoms, and alternative approaches for anxiety and insomnia.

Option 3: Empowering Patients: Integrative Behavioral Health in Substance Use Disorder Treatment This introductory workshop will allow for the exploration of the evidence and utility of incorporating education around lifestyle behavioral changes and complementary modalities to the treatment of SUDs. These interventions have the capability of helping patients in recovery to restore joy and prevent chronic illness that disproportionately affect them. Implementation of clinical practices and research that include lifestyle change education, complementary therapies, and group medical visits should be included across the continuum of SUD care.

### Option 1: Creating Public Access to Immediate MAT Starts: a Partnership Model linking Telemedicine Touchpoints to long-term Comprehensive Treatment

A publicly available helpline for opioid use disorder (OUD) can function similarly to tobacco quit lines but be tailored to the needs of opioid use disorder and medication for addiction treatment (MAT). These services can provide immediate connection to peer support and low-barrier access to buprenorphine, methadone, harm reduction resources, and linkage to ongoing care. Staffed by trained counselors/peers and addiction medicine specialists, these lines can offer brief motivational interventions, overdose prevention education, and real-time linkage to telehealth MAT providers as an interim step towards long-term engagement with treatment based in community health care centers and behavioral health outpatient programs. Around the county the MAT helpline concept is taking root at local and statewide levels as the single most practical and scalable strategy to increase initial engagement of people struggling with OUD.

This workshop will feature physician leaders from a set of innovative and successful regional programs in Los Angeles, San Francisco, and Oakland who will present actionable strategies to create sustainable and effective programs that build off a backbone of partnership between medical centers, behavioral health programs, and community touchpoints. Technology options, specific financing and sustainability models, traditional and non-traditional staffing options, evolving regulatory and compliance considerations, contracting details and integration with Cal-AIM will be described in this highly interactive workshop.

## Option 2: The Seven Deadly Sins: How to avoid the most common physician pitfalls and mistakes that result in medico-legal liability and unwanted patient outcomes

The presentation will present cases based upon the presenters' medico-legal experience illustrating the pitfalls and mistakes seen in cases. Drs. Kan and San Bartolomé serve as expert witnesses in civil and criminal cases for both plaintiff and defense. They will cover the common mistakes seen in treatment setting from outpatient to inpatient and the spaces in between. The workshop will prepare addiction medicine physicians to review their practice to ensure that they are working to the Standard of Care and exceeding it. We will discuss standards not taught to us during training and fellowship that are relevant to our daily practice. Addiction treatment runs the gamut as does liability in our practices. We will ensure that participants understand their legal and moral duties in providing appropriate care to our patients, and how to best prepare themselves to avoid unnecessary liability related to other stakeholders involved in care delivery.

### Option 3: Optimizing Motivational Interviewing Across Cultures for Busy Clinicians and Educators

Learn or refine your clinical and teaching skills in Motivational Interviewing (MI) adapting principles and techniques across diverse cultures. This workshop provides tools to engage our patients/clients who have unhealthy alcohol and drug use, as well as other lifestyle changes to promote behavior change commonly addressed in primary care and other specialties. Strategies will be developed through mentored learning in breakout groups with clinical skills acquisition and practice.
